What is new in the Recorder Office?

Full scale launch of Laredo Anywhere! We're very excited about Laredo's new feature. Searching by Laredo can be done literally anywhere you like with Laredo Anywhere. On your cell in the palm of your hand you can use this wonderful tool. There has been a gradual release for a few months with webinars to help you get the hang of it. Find the details at www.Fidlar.com under Laredo Anywhere. The guick start pages are 3.4.5. With Laredo Anywhere you create your own main account username/password then just ADD the Laredo county (usernames/passwords) that you have registered for access to and then you are good to go! Thank you Fidlar!

We're adding **eDEEDS** (conveyance documents) to our eRecording document types the end of March. Training will happen over a few weeks in April. This will allow eRouting approvals through three offices, Recorder, Auditor's Real Estate Transfer Office and the Engineer's Tax Map Office with 'doc-router' for any required approval stamps to be done electronically. Once our multiple offices are ready we'll be eRecording Deeds. We're looking forward to saving steps and time for everyone as we implement this modernization.

Fighting Property Fraud! This effort is going great! For the first two months of this year we are experiencing high interest with the registrations for our PFA (Property Fraud Alert) program registrations jumping to record numbers. The property owners of Lake County are signing up for this FREE, convenient and helpful alert service and we're thankful that our awareness campaign is working!

Standard Recording Guidelines Ohio Revised Code §317.114

- Computer font size of at least 10 point
- Minimum paper size 8 1/2 by 11 inches Maximum paper size - 8 1/2 by 14 inches
- Black or Blue ink ONLY
 - No use of highlighting
- Margins of 1 inch on each side and bottom of each page
- 3 inch margin on the top of the first page
 - 1 1/2 margin on the top of each of the remaining pages

The goal is document standardization. Recorder accepts any document even if it does not conform to these new guidelines. A charge of \$20.00 fee in addition to standard fees will apply. This law does not apply to any documents from any court or taxing authority, Plats, DD214's, any state or federal document, any documents executed before July 1, 2009
